We really appreciate everything that you have done over the years.

Congratulations to Christie Chatfield who volunteered to finish out the secretary's term. I appreciate the help.

A lot was discussed at the May quarterly, especially agency planning meetings. The BLM has held their two scoping meetings the first Monday and Tuesday of May. The final input will be available in early 2018. Thanks to those that attended, it made a difference with the agency personnel.

What is needed from all of you is to have your input to the BLM. This is very important, no matter what part of the state you are in. If you use any trails in the Black Canyon Corridor just north of Table Mesa your input is needed. Please make sure any trail easy to extreme is on the maps if not make sure you comment. We are the users and we need to be part of the process. Whether it is at a local level or a national level. These are our roads and trails so let's try to keep them open.

Another thing that is going on are bills in the federal government. One of importance is the Antiquities Act which was an executive order to review the act and give a report within 45 days. Then congress will issue a final report in 120 days.

Another executive order is to review 24 National Monuments, which include the Grand Parashant Vermillion Cliffs, Sonoran and Ironwood. Arizona has the most monuments of any state.

Senate Bill 33, to look at designation of only the area that is necessary to protect species or plants and not having to designate 2000 acres for it.

Anything that has to do with motorized recreation on public lands should be our main concern. These are our roads let's keep them open!

#### Help Wanted – ASP OHVAG

The Arizona State Parks will be asking for people to fill some positions on the Arizona State Parks Off Highway Vehicle Advisory Group (OHVAG) in December. I will not be able to serve another term at this point. So, there won't be anyone to represent full size 4-wheel drive vehicles. The advisory board is made up of mainly UTV, but also ATV and single track are on the board. I am the only one that has been there to represent full size vehicles.

## CHIVO FALLS & UPPER LOOP-3/18/17

Ding-ding-ding—Round 2 of the Tucson rough Riders versus Chivo Falls and the Loops. Or perhaps one could call this run "March Madness" Tucson Rough Rider's style. I'll let the reader be the judge. But quite a run it was.

Seventeen well-prepared 4-wheel-drive vehicles assembled at the McDonald's on Tanque Verde Road on Saturday morning. The day dawned clear and bright with the promise of being quite warm. Our trail leader for this round was Phil David—a very experienced 4-wheeler with a big knowledge of the run area. I had the privilege of riding with Leo O'Campo who is always full of surprises and adventures.

We headed up Redington Road and aired down in a small parking lot, then off to the Three Feathers entry point to our intended trail. Everyone made the Three Feathers entry OK and I was pleased we were off to a good start.

I don't know if it is my imagination or not, but the area seems to get more eroded every subsequent visit I make. The trail is a lot of work but is very rewarding relative to views and to those looking for 4-wheel-drive adventures. We all made the journey passing the Chivo Falls entrance to the left and then up Dead Man's Hill to the loop. As opposed to the very wet New Year's Day run, this was a dry climb and everyone made the uphill OK. Good, got that behind us.

We stopped at the "Cottonwoods" for a short break. This is a delightful area with a small brook running nearby. I had always been under the impression that the white-barked trees were cottonwoods. I was then informed that the dominant trees in the area are Sycamores. They are certainly majestic in stature and add to the ambiance of the area. Certainly to have a picnic in this area is well worth the trip.

We then headed off to our lunch spot which Phil David refers to as the "Sand Bar." This is truly a lovely spot but access is a bit of a challenge. This area is one of the main confluents to the Chivo Falls proper. I am sure by now you have seen the great pics posted by Tim Naylor of the run in the Photo Gallery Area of the website. here!] If you do not, do so as the pics are worth a million words. This area has lots of BIG water-filled holes. LARGE crevasses, and BIG rounded ROCKS! If your line is off a little bit you can find yourself in a whole lot of trouble. It took quite a while to get everyone in and settled.

Just a passing point—if you plan to do some challenging trails rated at 4 or above, you need a winch. We did a LOT of winching on this run and were it not for the winch expertise of our Hard-Rock members, some of us would still be out on the Loop. If you do not have one, a winch should be on your wish list.

Getting everyone out from the "Sand Bar" proved as much a challenge as getting everyone in. Jeeps falling in crevasses to the left and right—jeeps falling in big holes either forward or aft—quite a scene. Lots of winching going on. The Hard-Rock guys had a ball!

Now off to Three Feathers and our journey home. Most made it up OK. Some to the extreme right and some up the middle. Leo O'Campo decided to try another line up the middle and required the assistance of—you guessed it—a winch line to get himself out of a little jam. As I stated at the outset, riding with Leo is indeed an adventure in itself. Great company and a very interesting person—but brace yourself for an adventurous ride. Certainly not a dull moment.

Thanks for sharing the Rough Rider with us Dave! We're so lucky to live in Arizona with access to so many awesome trails—wish Tucson wasn't so far away! [Ed]

Mac has wanted to run this trail for some time so we accommodated him. Those with more testosterone than sense were Mac, Dan, Doug with Bob Smith as passenger, myself and Brent Phillip (frequent guest from Phoenix) and, of course, one of our many photographers and can-do gal, Joan.


The best way to describe this trail is ROCKS. No, let's change that to BOULDERS. Big ones. Some bigger than what we were driving. It starts out with those of reasonable size spaced many yards apart. As you progress the bite increases and the spacing decreases eliciting remarks like Holy Ship and Son of a Switch. Many of the obstacles required a little scouting to determine a best line and often a lot of spotting with even from time to time a few rocks (oh, horrors) stacked.

The mother clucker (chicken) will be fed at the upcoming meeting by Dan for a punctured tire (successfully plugged) and by me for a busted Heim joint on the draglink (many thanks to Doug who fixed it enough to get me out and back to my truck and trailer).

This trail is not a full-on buggy trail but the next thing to it. We managed only a little better than half of the full length in five hours. 1<sup>1</sup>/<sub>2</sub> crow miles end to end per USGS Topo map—more because of devious bends in the route. Maybe next time we'll jump in at the bail out point and finish the trail. Revenge would be sweet.
